ADDENDUM NO. 2:

- 1. Specification 08800 Glass and Glazing: Interior Impact Resistant glass is further described.
- Specification 11150 Basketball Goals, Scoreboards and Athletic Equipment: Scoreboard wireless controller is revised to Model MP-80. Shot clock shall be wireless, and hand switch is revised to Model HS-80. Goal Lights model is revised to wireless Model GL-7248-RF, for all back boards.
- 3. Drawing C-101: Revised gravel path. Added concrete walkway along Old Creek Road ROW per City of Greenville.
- 4. Drawing C-201: Revised gravel path. Added concrete walkway along Old Creek Road ROW per City of Greenville. Grades are revised along concrete walk. Revised water main fire line.
- 5. Drawing L-101: Revised to reflect revisions to C-101 and C-201.
- 6. Drawings A-101, A-102, A-401, A-402: Pre-engineered rigid frames are revised to be 12" deep in Gymnasium 114, boxed in with metal stud framing and 5/8" impact resistant gypsum wall board, to 14'-0" A.F.F. Exposed corners to be trimmed out with the specified corner guards. Bleachers top row to be notched (custom cut out) for described frame column wraps.
- 7. Drawing A-105 Clarification: Glazed Partition framing and door frame 105A for Manager 105 is aluminum storefront door frame and framing.
- 8. Drawing A-301, Door Schedule: Doors 114A and 114B are changed to door type AL-4 aluminum wide stile with impact resistant glass. Door Type AL-4 is added.

- 11. Drawing E-001: Revised the Riser Diagram to make the MDP a Main Circuit Breaker panel and to make P1 a 125A MLO panel. Revised the associated feeder size for P1. Eliminated General Note #39 that required the service conductors to be in concrete. Not required by GUC.
- 12. Drawing E-101A: Updated the panel schedules for the MDP and P1 changes.
- 13. Drawing E-102: Added the Keyed switches for the motorized goals.
