ADDENDUM NO. 3:

- 1. Clarification Form of Proposal, ref. ALT-4 and drawing K-101: the new gymnasium kitchen equipment referenced in ALT-4 on the Form of Proposal indicates equipment to be furnished under the BASE BID. This should say under ALT 1-C or ALT 1-P, since the gymnasium is under an alternate bid.
- 2. Specification Section 09900 Painting: Paint Systems Schedule is revised.
 - a. Interior masonry/concrete surfaces are scheduled for: Sherwin-Williams Pro-Classic Interior Alkyd Semi-Gloss, B34 Series.
 - b. Interior metal surfaces (including door frames) are scheduled for: Sherwin-Williams Industrial Enamel Alkyd Gloss Enamel, B54 Series.
 - c. Interior drywall surfaces are scheduled (unless otherwise noted) for: Sherwin-Williams Pro-Classic Interior Alkyd Satin, B33 Series
- 3. Terrazzo Clarification: The intent for new terrazzo is to match the existing terrazzo at the terrazzo areas to be patched. This includes providing a standard matching 400 grit finish in lieu of the 800 grit finish specified, and that marble and aggregate chips are to match existing.
